private start-ups where building the right team and meeting benchmarks for success are core principles.

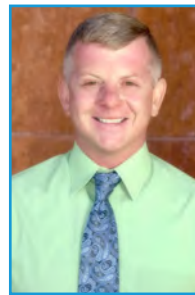


**Erin Brown**

councils, Children's Trust Fund, home visitation programs, infant and toddler mental health programs, and child maltreatment prevention.

Cheryl Ternes is the director of the Department of Human Services in Arapahoe County, Colorado, the state's third largest county, with a population of approximately 623,000. The Department provides child protection, foster care, adoption, adult protection, child support, and public assistance services.

Stephanie Villafuerte serves as Colorado's Child Protection Ombudsman. This state agency is an independent and neutral organization that serves as a resource and systems navigator for stakeholders and the general public, reviews complaints about the child protection system, and makes recommendations to the legislature and state government for system improvements.

**The Bell Policy Center**

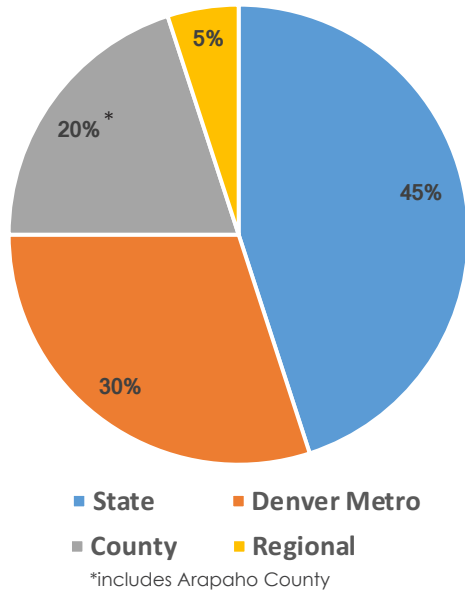

## GEOGRAPHIC INFLUENCE

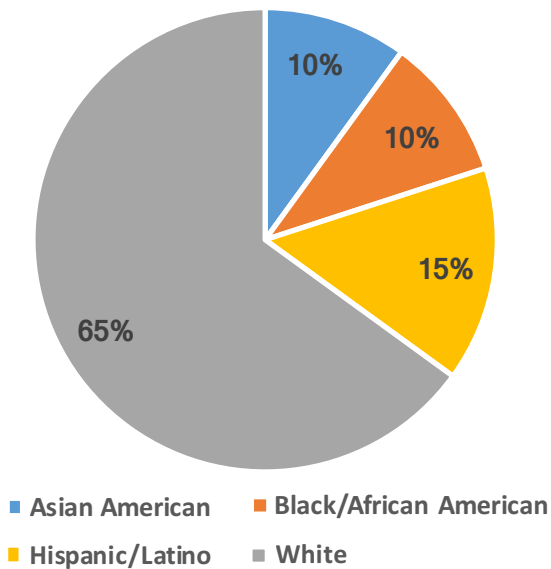

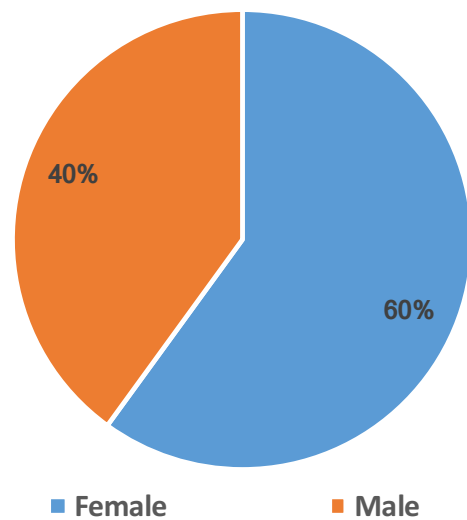

As a cohort, Fellows participate in four forums, interim check-ins and technical assistance, and an individual or collaborative action plan that furthers their existing work and goals. Specifically, the Fellowship:

- Explore values in leadership through text-based dialogue; and
- Leverage the Aspen Institute's wealth of leadership experience and resources.

### Amplifies big ideas and diverse voices

- Participate in signature Institute convenings, publications, and media platforms.

### Catalyzes change and innovation

- Build a high-trust, action-oriented network of social justice leaders to make a real difference in the lives of children and families; and
- Carry out action plans to spur new partnerships, scale approaches, and fuel creative strategies.
